



*Rules & Regulations*  
*Miss Spanish Festival Queen IV*  
*2018 Queen's Contract*

- I. Miss Spanish Festival Queen must be between the ages of 18-23 by October 1<sup>st</sup> 2018 and must be a resident of Louisiana. Miss Spanish Festival Queen must be single and remain so during the term of her reign. Miss Spanish Festival Queen must NOT be living with someone of the opposite sex or significant other, nor had a child.
- II. Miss Spanish Festival Queen must NOT hold any other titles, other than school or college, and may not enter any other pageants throughout their reign other than the Louisiana Association of Fairs and Festivals Queen of Queens pageant. Miss Spanish Festival Queen is given the opportunity to compete (not mandatory) for LAFF Queen of Queens pageant held in Baton Rouge February 21<sup>st</sup>-24<sup>th</sup> 2019. Miss Spanish Festival Queen is offered a paid entry fee to the pageant but is responsible for the hotel expenses. Miss Spanish Festival Queen shall attend the LAFF Convention and participate in all activities pertaining but does not have to compete in the pageant.
- III. The newly crowned Miss Spanish Festival Queen is required to travel throughout the state of Louisiana. In the event, if a Queen accepts an invitation to attend a function, she must present herself in a lady-like manner at all times. Any bad conduct while representing El Festival Español de Nueva Iberia will require an immediate dismissal. Miss Spanish Festival Queen must be present during the entire event as invited except in cases of illness, death, or the permission of the inviting director. Miss Spanish Festival Queen is expected to be dressed appropriately. No Jeans or Shorts, unless the invitation specifically recommends.
- IV. Miss Spanish Festival Queen is expected to act in a lady-like manner at all times. Any conduct inappropriate to a Queen while she is representing this festival will require immediate dismissal. The title and all privileges will be revoked immediately and will revert back to El Festival Español de Nueva Iberia. The following constitutes inappropriate conduct/behavior:
  - Posting inappropriate posts/photos on social media.
  - No nude or semi nude photos
  - Absolutely no photos of you drinking or smoking or the appearance of either, even if you are of the drinking age

- No photos with males or females that can be portrayed in a sexual nature i.e. kissing, etc.
- No vulgar comments left on your social media page as well as no vulgar words posted.
- Any and all photos and comments not following these guidelines MUST be taken down.

V. At any time the festival board reserves the right to discuss with you any content we deem inappropriate.

1. Disrespecting others on social media
2. Improper moral conduct or disrespect
3. Foul or Abusive language
4. Physical violence of any degree
5. Vulgar body display or vulgar dancing
6. Smoking, drinking of Alcohol while representing El Festival Español de Nueva Iberia.
7. Illegal drug use
8. Failure to abide by a hosting Festival or Organization rules
9. Poor Attitude
10. Usage of cell phone in a disruptive manner during an event for texting, social media, or talking.
11. Removal of the crown and banner while attending a festival does not exempt the queen from her responsibilities

VI. If any of the above rules are broken, the consequences are at the discretion of the director. Consequences may include, but are not limited to removal of title upon the Festival Board.

VII. Miss Spanish Festival Queen is expected but not limited to attend a minimum of (20) LAFF Events, at least (4) per quarter throughout her reign. Here are the required Festivals/Pageant events that the Miss Queen should attend, if invited:

*Louisiana Sugar Cane Festival, and/or Pageant - New Iberia  
Jr., Teen, & Miss Iberia Pageant- New Iberia  
Delcambre Shrimp Festival, and/or Pageant - Delcambre  
Erath's 4<sup>th</sup> of July Festival, and/or Pageant - Erath  
Louisiana Cattle Festival, and/or Pageant- Abbeville  
Rayne Frog Festival, and/or Pageant- Rayne  
Gueydan Duck Festival, and/or Pageant- Gueydan  
Breux Bridge Crawfish Festival, and/or Pageant- Breux Bridge  
International Rice Festival, and/or Pageant- Crowley*

VIII. Miss Spanish Festival Queen is required to send a quarterly report with her travel appearances and locations to the director.

- IX. Miss Spanish Festival Queen is required to attend New Iberia events where she is invited to, including but not limited to: New Iberia's 4<sup>th</sup> of July parade and activities, Acadiana Dragon Boat Races, Gumbo Cook-Off, Live Oak Festival, Christmas Parade, and Mardi Gras Parade. We also encourage the Miss Spanish Festival Queen to take part in volunteering/community service throughout her reign as queen. Miss Spanish Festival Queen is expected to participate in the Annual Spanish King's Ball in October 2019 and the Festival Poster Unveiling Ceremony in Spring 2019. Dates are to be determined!
- X. The newly crowned Miss Spanish Festival Queen agrees to spend the 2019 El Festival Español de Nueva Iberia April 26<sup>th</sup>-28<sup>th</sup> 2019, by participating in ALL events throughout the Festival weekend: Spanish Gala, Opening Ceremony, Royalty Presentation, Walking Parade, and Thanksgiving Mass for the founding Spanish Families.
- XI. Miss Spanish Festival Queen is responsible for the maintenance and carrying of her custom crown, formal banner, scepter, train and mantle, and custom crown and scepter box. If any destruction occurs of crown, banner, scepter, train and mantle, and the custom boxes, the Queen will be responsible for all expenses.
- XII. Miss Spanish Festival Queen agrees to allow El Festival Español de Nueva Iberia to use her information and photographs to promote the Spanish Festival. Miss Spanish Festival Queen agrees El Festival Español de Nueva Iberia, La Association de Nueva Iberia, and pageant director are not responsible for loss of personal belongings, accidents or illnesses during her travels.
- XIII. If any Queen feels that she cannot complete her (1) year required duties representing El Festival Español de Nueva Iberia, please inform! Remember as a Festival Queen, *with or without your crown and banner* you are a role model and to always have a positive perspective.
- XIV. Miss Spanish Festival Queen must attend the contract signing on Sunday, October 7<sup>th</sup> 2018. All rules and regulations will be reviewed; time and location will be determined!
