



# Rules & Regulations

## *Little Miss, Petite Miss, Deb Miss, & Junior King*

### 2022 Queens/King Contract

- I. Ages are as of October 1<sup>st</sup>, 2022: Little Miss must be between the ages of 4-5, Petite Miss must be between the ages of 6-8, Deb Miss must be between the ages of 9-11. Junior King must be between the ages of 5-7. All newly crowned Spanish Festival Royalty must be a resident of Louisiana.
- II. Little Miss, Petite Miss, Deb Miss, & Junior King are invited to travel throughout the State of Louisiana. In the event, if a Queen/King accepts an invitation to attend a function, she/he must always present themselves in a proper manner. Any bad conduct while representing El Festival Español de Nueva Iberia will require an immediate dismissal. Little Miss, Petite Miss, Deb Miss & Junior King must be present during the entire event as invited except in cases of illness, death of a family member, or the permission of the inviting director. Little Miss, Petite Miss, & Deb Miss Spanish Festival Queens are expected to be dressed appropriately. No Jeans or Shorts unless the invitation specifically recommends.
- III. Little Miss, Petite Miss, Deb Miss, & Junior King are responsible for the maintenance and carrying of custom crown and banner. If any destruction occurs of crown or banner the Queen/King will be responsible for the expenses.
- IV. If any of the above rules are broken, the consequences are at the discretion of the director. Consequences may include but are not limited to removal of title upon the Festival Board.
- V. Little Miss, Petite Miss, Deb Miss, & Junior King agree to spend the 9<sup>th</sup> annual El Festival Español de Nueva Iberia April 21<sup>st</sup> - 23<sup>rd</sup>, 2023. Queens/King will participate in various events throughout the Festival weekend, including: Spanish Heritage Parade, Opening Ceremonies and Royalty Introduction, Queen Day Activities and Thanksgiving Mass on Sunday.
- VI. Little Miss, Petite Miss, Deb Miss & Junior King are expected to participate in the Annual Spanish King's Ball on Friday, October 6<sup>th</sup>, 2023, and are also encouraged to participate in the Festival Poster Unveiling Ceremony in early spring 2023. Dates are to be determined!

- VII. Little Miss, Petite Miss, Deb Miss, & Junior King are invited to attend The City of New Iberia events including but not limited to: LA. Sugar Cane Festival, New Iberia's 4<sup>th</sup> of July parade and activities, Gumbo Cook-Off, Christmas Parade, Festival of Live Oaks, and Mardi Gras Parade.
- VIII. Little Miss, Petite Miss, Deb Miss, & Junior King agree to allow El Festival Español de Nueva Iberia to use her information and photographs to promote the festival. Little Miss, Petite Miss, Deb Miss, & Junior King agrees to NOT hold El Festival Español de Nueva Iberia, La Association de Nueva Iberia, and pageant director responsible for loss of personal belongings, accidents, or illnesses during her travels.
- IX. Little Miss, Petite Miss, Deb Miss, & Junior King must attend the contract signing on Sunday, October 2nd, 2022 at 2:00pm at The Lopez Residents: 8 Oak Place, New Iberia, LA 70563. All rules and regulations will be reviewed. After the contract signing, we will discuss plans for the annual Louisiana Association of Fairs and Festivals convention in Baton Rouge on February 2-5, 2023. If interested in attending the convention money will be collected at the contract signing. Packets for the weekend is \$170 per person (all ages) and does not include hotel stay.
